A Real Saint?

Mother Teresa was a Roman Catholic nun who lived from 1910 until 1997. During her lifetime, she was presented with many honours for her work with those living in poverty, the disabled and also the dying. The most famous of these accolades was the Nobel Peace Prize. In 2016, nineteen years after her death, Mother Teresa was Canonised meaning that she was made a saint. Since then, there has been some controversy over this with many scholars questioning the decision to make Mother Teresa a saint.

To be a saint, there is a strict five-step criteria to meet. Firstly, five years need to have passed since the death of the person. Secondly, the person in question has to be a servant of God, this means that they must have been devoted to God and his work. Next, the person has to be proved to have had a "heroic virtue". This means there needs to be evidence to suggest that they have set a good example and have encouraged people to worship God through prayer. Then, the person needs to have performed a miracle when they were living. Each miracle is investigated by the Vatican, and if the miracle is thought to be true the candidate can move on to the last stage of becoming a saint; Canonisation. Canonisation can only take place if another miracle happens after the person has died, and the miracle has happened when someone else has prayed for the candidate.

First of all, it was alleged that Mother Teresa performed a series of miracles. The first miracle being the healing of a tribal woman who had a large tumour. The woman, who had already received medical treatment, had a tumour which threatened her life. The lady, named Monica, moved into the home of the Missionaries of Charity to be nursed. During that time she felt a beam of light from a photograph of Mother Teresa, prayers were said to Mother Teresa and shortly after, the tumour had disappeared. Believers are sure that this is a miracle. Doubters believe that Mother Teresa should not be a saint because they are sure that no miracle happened. In fact, even Monica's husband did not believe it was a miracle, he thought that the tumour had disappeared thanks to all of the medical treatment Monica had before. How exactly can Monica have felt a beam of light from a photograph? Was it a trick of the light?

Moreover, to become a saint the individual must have performed several miracles both before and after their own death. Although the case of Monica and her tumour was decided by the Pope as a miracle, other events have been questioned. This is because a miracle is only called a miracle if someone is cured. Mother Teresa did not go and heal many people, but helped them have a better end of life. She kept them safe and comfortable when they were dying. Although this is all generous and kind work, it is not in fact a miracle, and this is why many people believe that she should not be named a saint.

Mother Teresa helped a large amount of people. This was evident when she was living amongst the poorest people in the slums in India. At this point in her life, Saint Teresa (as she is now called) worked hard to provide the basic needs to many people who were living in squalid conditions. This was selfless work, often going without food and water herself. Furthermore, she had already spent much time learning how to nurse before she left the safety of the convent to live amongst the people in most need. Although people believe she was generous, some sceptics ask why Mother Teresa left the convent to live amongst the poor. Surely it would have been better to keep herself fit and well by living in the convent whilst helping others in the slums?

Mother Teresa set up a foundation called the Missionaries of Charity. This foundation was set up to help those people that were sick and dying. People are able to visit the nineteen homes it has in Calcutta when they need help, which is run by nuns. This foundation has helped countless people who needed it and supported them to practice Christianity, however there has been severe criticism of the homes. Some doctors have made claims that various people were not treated well in the homes, were not given basic things such as clean water and others were just left. These doctors were comparing the care of the homes to those similar in the UK. Things have changed since then and it is thought that the homes provide better care now than they used to.

In conclusion, there has been great debate and speculation since the death of Mother Teresa on if she should have been made a saint or not. Despite the arguments for and against, the Catholic Church have investigated the claims and have found them to be true. Whatever you believe about Mother Teresa's work, the Pope has awarded her Canonisation and the title of Saint Teresa.
